TRANSFORMING PUBLIC JUSTICE: THE CIVIL RESOLUTION TRIBUNAL & MVA DISPUTES AN ESSENTIAL PRIMER FOR HEALTHCARE AND LEGAL PROFESSIONALS GUEST SPEAKER – SHANNON SALTER CHAIR OF THE BC CIVIL RESOLUTION TRIBUNAL

Shannon Salter, named one of the Top 25 Most Influential Lawyers in Canada, is the Chair of the Civil Resolution Tribunal, which now handles minor injury claims and disputes up to \$50,000 involving motor vehicle accidents. She will discuss the CRT's jurisdiction, the online "Solution Explorer", evidentiary rules, and how this will support access to justice.

Ms. Salter is a very accomplished lawyer and has been recognised for promoting access to justice. Ms. Salter previously served as vice chair of the Workers' Compensation Appeal Tribunal. Ms. Salter is currently a commissioner of the Financial Institutions Commission, vice president of the BC Council of Administrative Tribunals, a Law Society of British Columbia disciplinary hearing panel member, and a board member of the Canadian Legal Information Institute. She is a co-author of the BC Administrative Decision Maker's Manual, as well as a number of important legal journal articles. Ms. Salter is adjunct professor at the UBC Allard School of Law, teaching administrative law, legal ethics and professional regulation.
