"ARTIFICIAL INTELLLIGENCE" AND THE FUTURE OF LAW

GUEST SPEAKER - THE HONOURABLE MR. JUSTICE EDELMANN

Since the public release of ChatGPT in 2022, there has been widespread interest in the use and implementation of various "artificial intelligence" tools for generating text, creating documents and managing information related to legal work. Some of these technologies are already having a significant impact on the work of counsel, judges, experts and other legal workers. The presentation will discuss some of the legal, ethical and practical implications for the courts, justice system participants and the law.

Justice Peter Edelmann was appointed to the Supreme Court of British Columbia in 2019 and the Court of Appeal for British Columbia in October 2024. Receiving both LL.B. and Civil Law degrees from McGill University, he was called to the bar of British Columbia in 2005.

Throughout his legal career, he has been actively engaged in the implementation of technology in legal practice. From 2008 – 2012, he was an instructor in the Computer Forensics Programme at the British Columbia Institute of Technology. Prior to his appointment to the Court of Appeal, Justice Edelmann sat on the Joint Courts Technology Committee and now sits on the Court of Appeal's technology committee.
